County, State aforesaid, being known and designated as lot # 80 as shown on plat of the subdivision known as Augusta Road Ranches, recorded in the Office of R.M.C. for Greenville County in Plat Book "M" at Page 47, and being more particularly described, according to said plat, as follows:

BEGINNING at an iron pin in the Western side of Long Hill Street, joint front corner of lots # 79 and 80, and running thence with the joint lines of said lots, S. 89-47 W. 325 feet to an iron pin; thence N. 2-03 E. 60.06 feet to an iron pin, joint rear corner of lots # 80 and 81; thence with the joint lines of said lots, N. 89-47 E. 305 feet to an iron pin on the Western side of Long Hill Street; thence with said Street, S. 16-38 E. 62.5 feet to the beginning corner.
