Whereas, the said Better Home Builders, Inc.

in and by its certain Promissory note in writing, of even date with these presents, is well and truly indebted to Peoples National Bank

with interest thereon from date at the rate of Six per cent. per annum, to be computed and paid quarterly

County, State aforesaid, on the western side of Monteith Circle, partly within and partly without the City of Greenville, being shown as Lot No. 7 on Plat of the Property of O. Y. Brownlee, H. C. Smith and C. S. Fox made by Pickell & Pickell on February 16, 1948, recorded in Plat Book "Q" at Page 164 and described as follows:

BEGINNING at a stake on the northern side of Monteith Circle 365 feet east from the Old Augusta Road at corner of Lot No. 6 and running thence with the line of said lot N. 12-45 W. 137.8 feet to a stake at corner of Lot No. 8; thence with the line of said lot S. 47-55 E. 172.2 feet to a stake on Monteith Circle; thence with the northern side of Monteith Circle S. 70-45 W. 39 feet to a stake; thence continuing with said Monteith Circle S. 84-00 W. 61 feet to the beginning corner.
