Office in Plat Book "K", at pages 111 and 112, and having according to said plat the following metes and bounds:

BEGINNING at a pin on the north side on North Pliney Circle, at the southeast corner of lot # 12, and running thence along the north side of North Pliney Circle N. 70-15 E. 100 ft. to pin on corner of lot # 14; thence with line of lot # 14, N. 19-45 W. 200 ft. to pin; thence S. 70-15 W. 100 ft. to pin at rear corner of a street; thence along the rear end of said street and along line of lot # 12, S. 19-45 E. 200 ft. to the beginning corner, and being the same lot as conveyed to mortgagor by Horace Lynch by deed dated July 15, 1949, recorded in the Greenville County R.
