Fred Wilson Jones, of Greenville, S. C., hereinafter called the Mortgagor, send(s) greetings:

All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the Southeastern side of Sycamore Drive in the City of Greenville, S. C., being shown as lot #161 on the Plat of East Lynne Addition as recorded in the REC Office for Greenville County, S. C., in Plat Book "4", page 220, said lot fronting 50 feet on the Southeast side of Sycamore Drive and having a depth of 156.4 feet on the Southwest side, a depth of 154.3 feet on the Northeast side and being 50.05 feet across the rear.
