four per centum (4 %) per annum until paid, said principal and interest being payable

in Greenville, S. C., or at such other place as the holder of the note may
designate in writing delivered or mailed to the Mortgagor, in monthly installments of Thirty-three and 26/100

Dollars (\$ 33.26), commencing on the first day of
August, 19 50 and continuing on the first day of each month thereafter until the principal and
