All that tract of land located in Greenville Township, Greenville County, South Carolina, containing _____ acres, more or less, known as the _____ place, and bounded as follows:

All that certain tract of land containing Two Hundred Twenty Seven and Ninety Hundredths (227.90) acres, more or less, situate in the Fork Shoals community of Greenville County, State of South Carolina, and bounded now or formerly as follows: On the North by lands of T. P. Chapman, Ridgeway and King; on the South by land of John King; on the East by lands of George King Estate and by land of John and Ralph King; and on the west by land of Burns, Berry and T. P. Chapman. Said tract is made up of five parcels as shown on two plats prepared by J. Mac Richardson, R. L. S., dated January, 1955, and recorded in Plat Book II, Page 59, and Plat Book II, Page 59, R. M. C. Office for Greenville County, South Carolina. Said tract being conveyed to the mortgagors herein by two deeds as follows: (1) Deed of Evan D. Ginn, dated September 29, 1952 and recorded in said R. M. C. Office in book of Deed 463, Page 529; (2) Deed of Gladys B. Barber, dated September 29, 1952, and recorded in said R. M. C. Office in Deed Book 463, Page 535. The total acreage stated in said deeds is 220.5 acres, but the total acreage according to the two plats above mentioned is 227.90 acres, more or less.

UNDERSIGNED hereby binds himself, his heirs, executors, administrators and assigns to warrant and forever defend all and singular the said premises unto Lender, its successors and assigns, from and against Undersigned, his heirs, executors, administrators and assigns and all other person whomsoever lawfully claiming or to claim the same or any part thereof.

PROVIDED ALWAYS, NEVERTHELESS, that if Borrower shall pay unto Lender, its successors or assigns, the aforesaid indebtedness and all interest and other sums secured by this or any other instrument executed by Borrower as security to the aforesaid indebtedness, and shall perform all of the terms, covenants, conditions, agreements, representations and obligations contained in a certain recorded crop and/or chattel mortgage executed by Borrower to Lender according to the true intent of said Chattel Mortgage and/or Crop Lien, all of the terms, covenants, conditions, agreements, representations and obligations of which are made a part hereof to the same extent as if set forth in extenso herein, then this instrument shall cease, determine and be null and void; otherwise it shall remain in full force and effect.
