ALL that parcel, piece, or lot of land with the buildings and improvements thereon, situate, lying and being on the Northwest side of Prancer Avenue and on the West side of Long Hill Street, in the City of Greenville, in Greenville County, S. C., being shown as Lot No. 260 on Plat of Pleasant Valley, made by Dalton & Neves, Engineers, April 1946, recorded in the RMC Office for Greenville County, S. C., in Plat Book "P", page 92, and having according to said plat, the following metes and bounds, to wit:
