To All Whom These Presents May Concern:

I, B. J. Edwards,

SEND GREETINGS:

Whereas, I the said B. J. Edwards in and by my certain promissory note in writing, of even date with these presents, am (are) well and truly indebted to HOME BUILDING & LOAN ASSOCIATION, Easley, South Carolina, in the full and just sum of Four Hundred and no/100's . . . . . Dollars, (\$ 400.00 ) payable at the offices of said Association at Easley, South Carolina, with interest at the rate of Six per centum (6%) per annum, to be repaid in installments of Twenty Five and no/100's . . . . . (\$ 25.00 ) Dollars, due and payable upon the first day of each and every calendar month hereafter until the full principal sum with interest has been paid, said monthly installment to be applied first to the payment of interest, computed monthly on the unpaid balance, and then to principal; all interest, not paid when due to bear interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, then the whole amount evidenced by said note to become immediately due, at the option of the holder thereof, who may sue thereon and foreclose this mortgage; said note further providing for an attorney's fee of ten per cent, besides all costs and expenses of collection, to be added to the amount due on said note and to be collectible as a part thereof, if the same be placed in the hands of an attorney for collection, or if said debt, or any part thereof, be collected by an attorney, or by legal proceedings of any kind (all of which is secured under this mortgage); as in and by the said note, reference being thereunto had, will more fully appear.

NOW, KNOW ALL MEN, That I , the said B. J. Edwards , in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said HOME BUILDING & LOAN ASSOCIATION, Easley, South Carolina, according to the terms of the said note, and also in consideration of the further sum of Three Dollars, to me , the said B.J. Edwards , in hand and truly paid by the said HOME BUILDING & LOAN ASSOCIATION, Easley, South Carolina, at and before the signing of these Presents, the receipts whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said HOME BUILDING & LOAN ASSOCIATION, Easley, South Carolina, its successors or assigns:

"ALL that certain piece, parcel or tract of land in Paris Mountain Township, Greenville County, State of South Carolina, containing 34.25 acres, and having according to plat made by W. A. Hester, dated June 25, 1950, recorded in Plat Book "X", Page 8, the following metes and bounds, to-wit: BEGINNING at an iron pin on the Old Buncombe Road at joint corners with land now or formerly owned by G.W. Howard Estate, and running thence with the line of said property, S. 62 W. 32.19 chs to pin at corner of land heretofore conveyed to Paul J. Willis; thence with his line and a County road, S. 43-57 E. 250 feet; thence S. 66-30 E. 930 feet to pin at intersection of County Road and Old Buncombe Road; thence with the center of the Old Buncombe Road, S. 5-42 W. 125 feet; thence S. 3-30 E. 207.5 feet to pin at bend; thence leaving said road N.77 E. 6.11 chs. to pin on G & K Railway; thence with the right of way of said Railway N. 13 E. 10.82 chs. to ironpin; thence N. 47 W. 3.04 chs to pin on Old Buncombe Road; thence with said road, N. 41 E. 4.93 chs. to pin; thence N. 12½ E. 9.57 chs. to the BEGINNING corner; being bounded on the North by lands now or formerly owned by the G. W. Howard Estate; on the East by J. C. Roe; and on the South and West by Marchbanks and Paul J. Willis; being a part of the land conveyed to B. J. Edwards by F. M. Edwards by deed recorded in volume 182 at page 154, in the office of the Register of Mesne Conveyance for Greenville County, South Carolina."

It is understood and agreed that this mortgage is second to one executed by B. J. Edwards to Home Building & Loan Association, Easley, S.C., in amount of \$13,281.83, dated January 18, 1957, recorded in Book of Mortgages 703 at page 186, Greenville County records.

TOGETHER with, all and singular, the Rights, Members, Hereditaments and Appurtenances to the said Premises belonging or in anyway incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the Premises before mentioned unto the said HOME BUILDING & LOAN ASSOCIATION, its Successors or Assigns forever. And I (we) do hereby bind myself (ourselves), my (our) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the said HOME BUILDING & LOAN ASSOCIATION, its Successors or Assigns, from and against myself (ourselves), my (our) Heirs, Executors, Administrators and Assigns, and every person whomsoever lawfully claiming or to claim the name or any part thereof.
