

Beginning at a point on the west side of an alley that runs north from Cain Street between Jackson Street and Dunlap Street, which point of beginning is 151.8 feet north or almost north, in a straight line, from a point on the north side of Cain Street that is 174.6 feet west along the north side of Cain Street, from the northwest corner of Cain Street and Jackson Street, and which point of beginning is 160.8 feet east or almost east, in a straight line, from a point on the east side of Dunlap Street that is 158 feet north, along the east side of Dunlap Street, from the northeast corner of Cain Street and Dunlap Street, and from said point of beginning running thence north or almost north, in a straight line, partly along the west side of said alley, 52.2 feet to a point that is 158.3 feet east or almost east, in a straight line, from a point on the east side of Dunlap Street that is 205.5 feet north, along the east side of Dunlap Street, from the northeast corner of Cain Street and Dunlap Street; thence west or almost west, along a line, (which line if extended westerly would intersect a point on the east side of Dunlap Street that is 205.5 feet north, along the east side of Dunlap Street, from the northeast corner of Cain Street and Dunlap Street) 38 feet to a point; thence south or almost south, 51 feet to a point that is 37.8 feet westerly from the point of beginning; thence east or almost east 37.8 feet to the west side of said alley, hereinabove mentioned, and the point of beginning; all as shown on a blue print of survey of property of Columbia Baking Co., made by Ernest L. Boggus, P. E. & Surveyor, dated January, 1955, a copy of which is on file in the Office of the Atlanta Title Company; being the same property acquired by Columbia Baking Company in executor's deed from Frampton E. Ellis as executor of last will and testament of Mrs. Floy M. Cooleedge dated February 18, 1955, recorded February 22, 1955, in Deed Book 2968, page 538, Fulton County Records.

Tract 5: All that tract or parcel of land lying and being in the City of Atlanta in Land Lot 46 of the 14th District of originally Henry, now Fulton County, Georgia, more particularly described as follows:

Beginning on the east side of Dunlap Street at a point 158 feet north of the northeast corner of Dunlap Street and Cain Street; thence north along the east side of Dunlap Street 24 feet; thence east 123 feet; thence south 24 feet; thence west 123 feet to the point of beginning on Dunlap Street; being improved property having a house thereon known as No. 211 Dunlap Street, N. E., according to the present numbering of houses in the City of Atlanta; being the same property acquired by Columbia Baking Company in warranty deed from Mrs. Julia B. Williams dated October 18, 1954, recorded October 20, 1954 in Deed Book 2931, page 222, Fulton County Records.

Tract 6: All that tract or parcel of land lying and being in the City of Atlanta in Land Lot 46 of the 14th District of Fulton County, Georgia, more particularly described as follows:

Beginning at a point on the east side of Dunlap Street one hundred eighty-two (182) feet north from the northeast corner of Dunlap Street and Cain Street, which point is at the northwest corner of the property now or formerly owned by John Williams; running thence north along the east side of Dunlap Street twenty-three and five-tenths (23.5) feet; thence east one hundred twenty (120) feet, more or less, to the property now or formerly owned by Mrs. Floy M. Cooleedge; thence south along the west line of said property twenty-five (25) feet to the northeast corner of the Williams property, hereinabove referred to; thence west along the north line of said property one hundred twenty-one (121) feet, more or less, to the east side of Dunlap Street and the point of
