\$34.82 per month, commencing one month from date and to continue until paid in full, with each payment applied first to interest and balance to principal,

South Carolina National Bank as Trustee under Agreement with Jack H. Long dated 4/3/57, its successors and assigns forever,

ALL that piece, parcel or lot of land with the buildings and improvements thereon situate on the North iside of 8th Street in Section 4 of Judson Mill Village, near the City of Greenville, being known and designated as LOT NO. 17 as shown on a plat of Section 4 in Judson Mill Village made by Dalton & Neves, Engr. in January, 1941; which plat is recorded in the RMC Office for Greenville County in Flat Book K, at pages 75 and 76 and having the following metes and bounds to wit:

BEGINNING at an iron pin on the North side of 8th Street at joint corner of Lots 17 and 18, said pin also being 110 feet East from the Northeast corner of the intersection of 8th Street and 2nd Avenue, and running thence with the rear line of Lot 18, North 1-42 West 80.6 feet to an iron pin in the line of Lot 19; thence with the line of Lot 19, North 88-10 East 71.5 feet to an iron pin in line of Lot 16; thence with the line of Lot 16, South 1-42 East 80.5 feet to an iron pin on the North side of 8th Street; running thence South 88-03 West 71.5 feet to the beginning corner.
