"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs, Township, on the west side of Poplar Drive (New Pelham Road) in the City of Greer, and being Lot No. 3 of the G.W. Neeley Estate according to surfey and plat by H.S. Brockman, Surveyor, dated March 24, 1937, and having the following courses and distances, to-wit:

BEGINNING on an iron pin on the west side of the said Poplar Drive, and being the joint corner of Lots 2 and 3, and runs thence with the western edge of the said Drive, N. 0-30 E. 55 feet to an iron pin on the western edge of the said Drive and being the joint corner of property of Mrs. I.M.
