SEND GREETING:

Whereas, the said MARSMEN, INC.

a corporation chartered under the laws of the State of South Carolina, in and by its certain promissory note in writing, of even date with these presents, is well and truly indebted to Helen L. Terry in the full and just sum of ONE THOUSAND AND NO/100 (\$1,000.00) DOLLARS

, to be paid \$25.00 on Sept. 10, 1957 and \$25.00 on the 10th day of each and every month thereafter until Sept. 10, 1960 when the balance of principal and interest shall be due and payable. From each monthly payment, interest shall be first paid and the balance credited as a principal reduction

, with interest thereon from date

at the rate of six per centum per annum, to be computed and paid monthly

until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorney's fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

at and before the signing of these Presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released and by the Presents does grant, bargain, sell and release unto the said Helen L. Terry, her Heirs and Assigns forever;

All that piece, parcel or tract of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina, and being known and designated as Tract Number 271 on a plat of Augusta Acres, Property of Marsmen, Inc., recorded in the R. M. C. Office for Greenville County in Plat Book S, Page 201 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the East side of Churchill Circle, joint corner of Tracts Numbers 270 and 271 and running thence with line of Tract Number 270, N. 80-36 E. 485 feet to an iron pin; thence 50 feet, more or less, to a stake on Old River Bed; thence with Old River Bed in a Northeasterly direction 340 feet, more or less, to a stake in line of Tract Number 272; thence with line of Lot Number 272, S. 77-20 W. 651 feet, more or less, to an iron pin on the East side of Churchill Circle; thence with Churchill Circle, S. 8-53 W. 205.1 feet to an iron pin; thence still with Churchill Circle S. 11-51 W. 44.9 feet to an iron pin, the beginning corner, containing 3.2 acres, more or less.
