ALL that lot of land with the buildings and improvements thereon, situate on the North said of Pendleton Street in the City of Greenville, in Greenville County, State of South Carolina, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Pendleton Street at the Southwest corner of lot formerly of Mrs. G. A.
