"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

In Paris Mountain Township, on the Western side of Strawberry Drive, being shown as Lot No. 29 on Plat of Blueberry Park recorded in the R.M.C. Office for Greenville County in Plat Book BB, at page 18, and having, according to said Plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Strawberry Drive, 150 feet from Leland Circle, and at the joint front corner of Lots Nos. 30 and 29, and running thence with the Western side of Strawberry Drive, N. 3-05 E. 80 feet to an iron pin, corner of Lot No. 28; thence with the line of Lot No. 28, N. 86-55 W. 158 feet to an iron pin; thence S. 3-10 W. 80 feet to an iron pin, corner of Lot No. 30; thence with the line of Lot No. 30, S. 86-55 E. 158 feet to the point of beginning.
