To All Whom These Presents May Concern: I, Rita Price Peeples,

the Mortgagor(s), SEND GREETING:

hereinafter called

WHEREAS, the said Mortgagor(s) in and by her certain promissory note in writing, of even date with these Presents, is well and truly indebted to The First National Bank of Greer

hereinafter called Mortgagee, in the full and just sum of Ten Thousand (\$10,000.00) - - - - - DOLLARS, to be paid as follows: \$150.00 on December 1, 1957, and \$150.00 on the first day of each month thereafter until interest and principal are paid in full, said payments to be applied first to interest and the balance to the principal, with the privilege of paying additional amounts on the principal on any payment date, with interest thereon from date, at the rate of five per centum per annum, to be computed and paid monthly, as stated above, until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note should be placed in the hands of an attorney for suit or collection the Mortgagor(s) agrees to pay all costs and expenses including a reasonable amount as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, That the said Mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor(s) paid by the said Mortgagee at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Mortgagee, The First National Bank of Greer, a corporation, its Successors and Assigns:

All that certain parcel or lot of land situated on the west side of Clear View Drive Extension, about Two (2) miles northward from the City of Greer, Chick Springs Township of Greenville County, State of South Carolina, and being Lot No. 9 of the property of W. Dennis Smith according to survey and plat by H.S. Brockman, Registered Surveyor, dated September 14, 1957, and having the following courses and distances, to-wit:

BEGINNING at a stake on the west side of Clear View Drive Extension, corner of Lots Nos. 8 and 9, and running thence along said Drive, S. 0-06 E. 110 feet to a stake, corner of Lot No. 10; thence S. 88-17 W. 193 feet to a stake, corner of Lot No. 2; thence along the line of Lot No. 2, N. 0-10 W. 102.5 feet to a stake, corner of Lot No. 8; thence along the line of Lot No. 8, N. 89-29 E. 193.3 feet to the beginning corner.
