interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including to perform the small beatless as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

Park, his heirs and assigns, All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, in City of Greenville, on the northern side of Orange Street (formerly Angel Avenue), at an iron pin at corner of the Lucinda Daniel property and the lot of land former ly owned by P. Rogers, and running thence in a westerly direction along the North side of Orange Street, Sixty (60) feet to a stake; thence in a northerly direction along a line parallel to the western line of the Rogers lot, One Hundred (100) Feet to a stake; thence in an easterly direction, along a line parallel to the North line of Orange Street, Sixty (60) feet to a stake on the western line of the Rogers lot; thence along the western line of the Rogers lot, in a southerly direction, One Hundred (100) feet to the point of beginning.
