aforesaid, and for the better securing the payment thereof, according to the terms of the said note, and
also in consideration of the further sum of Three Dollars, to me in hand well and truly paid at and before
the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, have granted,
bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said
Peoples National Bank of Greenville, South Carolina

all that tract or lot of land in
Greenville Township, Greenville County, State of South Carolina.

BEGINNING at an iron pin on Argonne Drive, joint corner of lots
Nos. 30 and 31 and running thence with line of lot No. 30, S. 48-50
W. 180 feet to an iron pin, joint corner of lots Nos. 30, 31, 37 and
36; thence S. 41-10 E. 71 feet with line of lot No. 36 to an iron
pin, joint corner of lots Nos. 31, 32, 35 and 36; thence N. 48-50 E.
180 feet with line of lot No. 32 to an iron pin on Argonne Drive;
thence N. 41-10 W. 71 feet with Argonne Drive to beginning corner.
Being known and designated as lot No. 31 on Plat of property of
C.B. Martin made by R.E. Dalton, Engineer, February, 1923 and re-
