TO ALL WHOM THESE PRESENTS MAY CONCERN:

LESLIE & SHAW, INC.

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Five Thousand Fifty and No/100ths-----

DOLLARS (\$5,050.00 ), with interest thereon from date at the rate of six-----  
per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable,  
July 1, 1969

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in Greenville Township, Greenville County, State of South Carolina, being known and designated as Lots Nos. 32 and 33 as shown on a plat entitled "Property of Leslie & Shaw, Inc." prepared by C.C. Jones & Associates, dated February, 1957, and recorded in the R.M.C. Office for Greenville County, S.C., in Plat Book NN at page 3, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the Northeastern side of Nuggat Street at the joint front corner of Lots Nos. 31 and 32, and running thence with the line of Lot No. 32 N. 52-09 E. 118.6 feet to an iron pin in the rear line of Lot No. 29; thence with the rear lines of Lots Nos. 29 and 28 N. 12-06 W. 72 feet to an iron pin; thence with the rear lines of Lots Nos. 25 and 24 N. 49-48 W. 41.7 feet to an iron pin at the joint rear corner of Lots Nos. 33 and 34, and running thence with the line of Lot No. 34 S. 65-52 W. 141.7 feet to an iron pin on the Northeastern side of Nuggat Street; thence with the Northeastern side of Nuggat Street S. 31-00 E. 30 feet to an iron pin; thence continuing with the Northeastern side of Nuggat Street S. 37-51 E. 44.5 feet to an iron pin; thence still continuing with the Northeastern side of Nuggat Street S. 37-51 E. 65 feet to the point of beginning.
