WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Ninety-five Hundred and No/100** ----- DOLLARS (\$ 9500.00), with interest thereon from date at the rate of **five & three-fourths** per centum per annum, said principal and interest to be repaid as therein stated, and **(5 3/4%)**

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville, on the western side of Wilton Street, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Wilton Street, which pin is 140 feet N. 1-41 E. from the intersection of Croft and Wilton Streets and running thence with Wilton Street N. 1-41 E. 65 feet to pin; thence N. 83-17 W. 158 feet 9 inches to pin; thence S. 1-41 W. 65 feet to pin; thence S. 83-17 E. 158 feet 9 inches to an iron pin, point of beginning.
