All that certain lot of land in Greenville Township, Greenville County, State of South Carolina, situate on the Eastern side of Woodbriar Court, being shown as lot #19 on plat of Woodbriar, recorded in Plat Book EE at Page 6, and having according to said plat the following metes and bounds, to-wit:
