"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, known and designated as Lot 15 on plat of the property of E. D. Sloan recorded in Plat Book EE at Page 135, and having according to said plat the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the eastern side of Boxwood Lane at joint front corner of Lots 14 and 15 and running thence with the line of Lot 14 N. 69-34 E. 200 feet to pin; thence S. 17-31 E. 105.8 feet to iron pin at rear corner of Lot 16; thence with the line of Lot 16 S. 75-24 W. 200 feet to an iron pin on Boxwood Lane; thence with the eastern side of Boxwood Lane N. 17-31 W. 85.5 feet to the point of beginning."

Said premises being the same conveyed to the mortgagors by deed recorded in Deed Book 579 at Page 247.
