WHEREAS, the Mortgagor is well and truly indebted unto

AIKEN LOAN & SECURITY COMPANY

, a corporation organized and existing under the laws of South Carolina, hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Ten Thousand Eight Hundred Dollars (\$10,800.00), with interest from date at the rate of five & one-fourth per centum (5 1/4 %) per annum until paid, said principal and interest being payable at the office of Aiken Loan & Security Company in Florence, South Carolina, or at such other place as the holder of the note may designate in writing, in monthly installments of Seventy-two and 79/100 Dollars (\$72.79), commencing on the first day of February, 1958, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of January, 1978.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that lot of land in the County of Greenville, State of South Carolina, known and designated as Lot No. 12 on plat of Hughes & Cale subdivision recorded in Plat Book EE, page 128 of the R.M.C. Office for Greenville County, and having according to said plat and a recent survey made December 1957 by R. W. Dalton, the following metes and bounds, to wit:

BEGINNING at an iron pin on the north side of Cahu Drive, the joint front corner of Lots Nos. 11 and 12; thence with the north side of said drive, N. 85-29 W. 80 feet to an iron pin, corner of Lot No. 14; thence with the line of said lot, N. 4-31 E. 100 feet to an iron pin, corner of Lot No. 13; thence with the line of said lot, N. 43-01 E. 110.4 feet to an iron pin; thence S. 85-29 E. 11.3 feet to an iron pin, corner of Lot No. 11; thence with the line of said lot, S. 4-31 W. 186.4 feet to the beginning corner.
