The South Carolina National Bank, of Greenville, S.C., Its Successors and Assigns: All that piece, parcel or lot of land in \_\_\_\_\_ Township, Greenville County, State of South Carolina, in City of Greenville, lying east of the Laurens Road on the western side of Ridgeway Drive, being known and designated as Lot Number One Hundred Eighty Three (No. 183) on plat of East Lynne Addition, same recorded in Plat Book "H" at page 220 in R.M.C. office for Greenville County, and, according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Ridgeway Drive, at the joint corner of Lots Nos. 182 and 183, and running thence with the joint line of said lots, N. 69-42 W. 146.1 feet to an iron pin; thence with the joint line of Lots Nos. 162 and 183, N. 17-50 E. 50.05 feet to an iron pin; thence with the joint line of Lots Nos. 183 and 184, S. 69-42 E. 143.2 feet to an iron pin on the western side of Ridgeway Drive; thence with the western side of said Ridgeway Drive, S. 14-32 W. 50.25 feet to the beginning corner.
