"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs, Township, on the northern side of Virginia Avenue near the City of Greer (now in the new City Limits of Greer), and being known and designated as Lot No. 28 on plat of Development No. 2, Victor - Monaghan Company, Dividion of J.P. Stevens & Co., Inc., Greer plant, prepared by Dalton & Neves, Engineers, April, 1947, recorded in the Office of R.M.C. for Greenville County in Plat Book "P", at page 119, and having, according to said plat, the following metes and bounds, to-wit:
