All that certain parcel or tract of land containing 20 acres, more or less, situated on the west side of the old Greenville Road, near Pleasant Hill Church, in Highland Township, Greenville County, State of south Carolina, bounded by lands of H.B. Duncan, Lance Barton, and M.P. Lindsay, and having the following courses and distances, to-wit:
