(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto GREER FEDERAL SAVINGS AND LOAN ASSOCIATION, GREER, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing 8.2 acres, more or less, being Lots Nos. 1, 2, 3 and 4 as shown on plat for A. Walker Brasack, dated August 31, 1955, and having the following courses and distances, to-wit:

BEGINNING at a nail in Dr. Morrow Road, also called the Spartanburg Road, and running thence (old iron pin reference on line at N. 35-05 E. 31.9 feet), N. 35-05 E. 572.9 feet with Campbell land to old stone corner; thence with Atkins line, N. 75-30 E. 650.5 feet to stake; thence S. 11 E., more or less, (scale) 406 feet, more or less (scale) to nail in said road; thence with said road, S. 75-15 W. 351.8 feet to nail in road; thence S. 69-45 W. 308.2 feet to stake; thence S. 80-15 W. 236.9 feet to nail; thence N. 88-45 W. 166.9 feet to the beginning corner.
