WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, being known and designated as Lot 5 as shown on plat of the property of Liberty Park, recorded in Plat Book EE at page 145, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Proffitt Circle, front corner of Lots 4 and 5; running thence with the line of said lots, N. 89-17 W. 170 feet to an iron pin; thence S. 0-43 W. 100 feet to an iron pin; thence with the line of Lot 6, S. 89-17 E. 170 feet to an iron pin on said circle; thence with the said circle, N. 0-43 E. 100 feet to the beginning.

Being the same property conveyed to mortgagor by deed of M. G. Proffitt of even date herewith to be recorded.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
