sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,

All that certain piece, parcel or lot of land, with the buildings and improve-
ments thereon, lying and being at the northwesterly corner of the intersection of
Williams Drive with a 20 foot alley, near the City of Greenville, S. C., and being

Greenville County, S. C. in Plat Book S, page 109.
