RICHARD M. PARRIS AND ELIZABETH L. PARRIS of
Greenville, South Carolina, hereinafter called the Mortgagor, send(s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto

(5-1/4%) per annum until paid, said principal and interest being payable at the office of
C. Douglas Wilson & Co. in Greenville, South Carolina,
or at such other place as the holder of the note may designate in writing, in monthly installments of
Seventy-Four and 66/100----- Dollars (\$ 74.66),
commencing on the first day of June, 19 58, and on the first day of each month there-
after until the principal and interest are fully paid, except that the final payment of principal and interest,
if not sooner paid, shall be due and payable on the first day of May, 1988.

Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better
securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three
Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing
and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained,
sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its
successors and assigns, the following-described real estate situated in the County of Greenville,
State of South Carolina:

All that piece, parcel or lot of land, with the buildings and improvements thereon,
situate, lying and being near the City of Greenville, in the County of Greenville,
State of South Carolina, being known and designated as Lot 91, on Plat of Super
Highway Home Sites, which plat is recorded in the RMC Office for Greenville
County, South Carolina, in Plat Book P, page 53, and having, according to said
plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Shadow Lane, joint front corner
Lots 91 and 92, said iron pin being 849.6 feet from the intersection of Shadow
Lane and Meridian Avenue; and running thence N. 88-0 W. 182.5 feet to an iron
pin, joint rear corner Lots 91 and 92; thence along a 5 foot strip reserved for
utilities N. 2-0 E. 80 feet to an iron pin, joint rear corner Lots 90 and 91; thence
S. 88-0 E. 182.5 feet to an iron pin on Shadow Lane, joint front corner Lots 90
and 91; thence along Shadow Lane S. 2-0 W. 80 feet to an iron pin, the point of
beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belong-
ing or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be
had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter
attached to or used in connection with the real estate herein described.

To HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and
assigns forever.

The Mortgagor covenants that he is lawfully seized of the premises hereinabove described in fee simple
absolute, that he has good right and lawful authority to sell, convey, or encumber the same, and that the
