WHEREAS, the Mortgagor is well and truly indebted unto South Carolina National Bank of Greenville, S. C. (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Two Thousand and Fifty and No/100-----

DOLLARS (\$2050.00)

with interest thereon from date at the rate of Six per centum per annum, said principal and interest to be repaid: \$62.37 on June 19, 1958, and a like payment of \$62.37 each on the 19th day of each month thereafter until paid in full, said payments to be applied first to interest and balance to principal, with interest thereon from date at the rate of six per cent, per annum, to be computed and paid monthly

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee pursuant to the covenants herein and also in consideration of the further sum of Three (\$3.00) Dollars to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, his heirs, successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

being part of lot # 55 as shown on plat recorded in Plat Book F at Page 77, and described as follows:

"BEGINNING at an iron pin at the intersection of Lewis and Owens Streets, and running thence along Owens Street, S. 10-15 E. 200 feet to an iron pin, corner of lot 54; thence with the line of said lot, N. 79-45 E. 60 feet to iron pin; thence N. 10-15 W. 200 feet to an iron pin on Lewis Street; thence with the Southern side of Lewis Street, S. 79-45 W. 60 feet to the beginning corner."

Being the same property conveyed to the mortgagor by deed recorded in Book of Deeds 369 at Page 261.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
