JANE A. STEWART

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of **Fifty-three Hundred and No/100** -----
DOLLARS (\$ 5300.00), with interest thereon from date at the rate of five & three-fourth per centum per annum, said principal and interest to be repaid as therein stated, and (5 3/4%)

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, about five miles southeast from Greenville, on the west side of the Fred Hudson Road, bounded on the northwest and south by other lands of Fred H. Hudson, on the east by lands of Green, and described as follows:

BEGINNING at an iron pin on the east side of said road at a distance of about 75 feet from the Greenville-Pelham Road, and being on the Green line and running thence with the Green line N. 4-45 W. 289 feet to an iron pin on the said line; thence a new line S. 85-45 W. 435 feet to an iron pin; thence another new line S. 4-15 E. 12.7 feet to an iron pin on the west bank of the Creek at the root of a cluster of maples; thence another new line S. 73-30 E. 462 feet to the beginning corner, and containing 3.07 acres, more or less.

The above described lot is a part of Tract No. 2 as shown on plat of Perry Hudson Lands prepared by Dalton & Neves, November 1928.

Being the same premises conveyed to the mortgagor by deeds recorded in Deed Book 425, Page 286, and Deed Book 310, Page 303.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
