Now, Know All Men, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, within the corporate limits of the City of Greenville being known and designated as Lot No. 5 of a subdivision known as Hutton Court as shown on a plat thereof being recorded in the R.M.C. Office for Greenville County in Plat Book NN at Page 101 and having according to a more recent survey prepared for Joe L. and Margaret H. Nash by Jones and Sutherland, Engineers, dated July 15, 1958 the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Hutton Court, joint front corner Lot Nos. 5 and 4 and running thence with the line of said lots, S. 73-39 W. 202.1 feet to an iron pin; thence N. 6-15 W. 66 feet to an iron pin, joint rear corner Lots Nos. 5 and 6; thence with the joint line of said lots, N. 73-39 E. 174.1 feet to an iron pin on the Western side of the turnaround on Hutton Court; thence with the turnaround on Hutton Court following the curvature thereof, the chord of which being S. 63-11 E. 22.5 feet to an iron pin on the Western side of Hutton Court; thence continuing with Hutton Court, S. 16-21 E. 49.7 feet to an iron pin, the point of beginning.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.
