All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the Eastern side of a county road leading from Highway #29 to Lee Road (Donnan Road), near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as a major portion of Lot No. 12, as shown on a plat prepared by Dalton & Neves, dated February, 1941, entitled "Property of James Edwards" unrecorded, and having according to said plat and also according to a more recent plat prepared by Piedmont Engineering Service, dated March 8, 1949, entitled "Property of Clyde E. Kelley", the following metes and bounds:

BEGINNING at an iron pin on the Eastern side of Donnan Road, which iron pin is located 1,000 feet from the Southeastern corner of the intersection of Lee Road and Donnan Road at the joint front corner of Lots Nos. 11 and 12, and running thence with the line of Lot No. 11 N. 76-17 E. 222 feet to an iron pin in the line of Lot No. 10; thence with the line of Lot No. 10 S. 14-08 E. 90 feet to an iron pin in the line of Lot No. 10, which iron pin is 10 feet North of the joint rear corner of Lots Nos. 12 and 13; thence a new line through Lot No. 12 S. 76-21 W. 227 feet to an iron pin on the Eastern side of Donnan Road, which iron pin is 10 feet North of the joint front corner of Lots Nos. 12 and 13; thence with the Eastern side of Donnan Road N. 10 W. 90 feet to the point of beginning.
