BEGINNING at an iron pin on the Northern side of an unnamed street (generally known as Cuttino Circle), joint front corner of Lots Nos. 2 and 3, and running thence with the joint line of said lots, N. 0-44 W. 119.7 feet to an iron pin, joint rear corner of Lots Nos. 2 and 3; thence with the rear line of Lot No. 3, N. 78-31 E. 82.8 feet to an iron pin on the Western side of Franjo Street; thence with the Western side of Franjo Street, S. 1-57 E. 119.6 feet to an iron pin at the intersection of Franjo Street and an unnamed street (generally known as Cuttino Circle); thence with the Northern side of an unnamed Street (generally known as Cuttino Circle), S. 78-31 W. 84.9 feet to the beginning corner; being a portion of the property conveyed to me by Chinar McSwain Powell by deed dated June 5, 1958, and recorded in the R.
