(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Fourteen Hundred Fifty and No/100------

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

in Greenville Township, being known and designated as lot # 57, of Section 6 of the Judson Mills Village as shown on plat of same recorded in the office of R.M.C. for Greenville County in Plat Book "K" at Pages 106 and 107, and being more particularly described, according to said plat, as follows:

BEGINNING at an iron pin on the western side of "D" Street, joint corner of lots # 57 and 58, and running thence with the lines of lots # 58 and 59, S. 1-37 E. 132.2 feet to an iron pin, corner of lots # 56 and 60; thence with the line of lot # 56, N. 88-20 E. 76.6 feet to an iron pin on the western side of "D" Street; thence with "D" Street, N. 1-37 W. 49.6 feet to an iron pin; thence continuing with "D" Street, N. 24-52 W. 18.2 feet to an iron pin; thence still continuing with "D" Street, N. 48-06 W. 95.7 feet to the beginning corner."
