All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, on the Eastern side of Springfield Avenue, being known and designated as lot # 34, of the property of James H. Campbell according to a plat thereof prepared by C. C. Jones, Engineer, June 1951, and recorded in the R.M.C.
