"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Greenville Township, between North Franklin Road, and Darlington Avenue, in the Sans Souci Section of Greenville County, about three miles north of the City of Greenville, said lot having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern edge of a five (5) foot sidewalk running along Berkley Avenue, said pin being the joint front corner of Lots Nos. 22 and 23; and running thence with the southern side of said sidewalk S. 80-52 E. 60 feet to an iron pin, joint front corner of Lots 21 and 22; thence with the western line of Lot No. 21 S. 9-08 W. 133.4 feet to an iron pin, joint rear corner of Lots 21 and 22; thence with the rear line of Lot 26 N. 80-03 W. 60 feet to an iron pin, joint rear corner of Lots 22 and 23; thence along the eastern line of Lot No. 23 N. 9-08 E. 132.5 feet to an iron pin, the beginning corner, said lot being known and designated as Lot No. 22 on plat of the property of Ethel Y. Perry, recorded in the R. M. C. Office for Greenville County in Plat Book R at Page 127.
