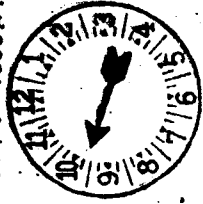

Whereas, I, the said Roy A. Collins

at the rate of six per centum per annum, to be computed and paid annually
until paid in full; all interest not paid when due to bear

interest at same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note, after its maturity, should be placed in the hands of an attorney for suit or collection, or if before its maturity it should be deemed by the holder thereof necessary for the protection of his interests to place and the holder should place the said note or this mortgage in the hands of an attorney for any legal proceedings, then and in either of said cases the mortgagor promises to pay all costs and expenses including 10 per cent. of the indebtedness as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

All that certain tract of land in O'Neal Township, State and County aforesaid, having the following courses and distances, to wit:-

BEGINNING at a stake in the center of road, in front of my home, and runs thence with said road N 29-40 W 1.09 chs. to iron pin, corner of the 5.92 Acres tract; thence continuing with said road to iron pin, the other front corner of the 5.92 Acres tract; thence continuing with said road N 38-47 W 3.67 chs.; thence N 42-08 W 5.40 chs.; thence N 50-38 W 3.03; thence N 54-34 approximately 3.39 chs. to a new corner of tract sold off; thence a new line S 21.30 W 413 feet to a new corner on the original line, and corner of tract sold; thence S 46-30 W 210.5 feet to stone; thence S 18-45 W 18.55 chs. to stone; thence S 71-30 E 12.72 chs. to stone, W. S. Dill corner; thence with the Dill line N 55-15 E 21.40 chs. to the beginning corner. Containing 48.5 Acres, more or less, less 3/4 Acre sold off the North-West corner of said tract.
