All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 208, as shown on a plat prepared by Dalton & Neves, Engineers, dated May, 1933, entitled "East Lynne Addition", recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book H at page 220, and having according to said plat the following metes and bounds:
