due and payable on the 5th day of each and every calendar month hereafter until the full principal sum, with interest and all costs, insurance, and expenses incurred in connection with said loan, has been paid, said monthly payments to be applied first to the payment of interest, and then to payment of principal, costs, expenses and insurance, if any, incurred; and said note further providing that if at any time any portion of the principal or interest due hereunder shall be past due and unpaid for a period of sixty (60) days, or upon failure to comply with any of the by-laws of said Association, or with any of the stipulations of this mortgage, the whole amount due under said note, shall at the option of the holder become immediately due and payable, and said note further providing for a reasonable attorney's fee besides all costs and expenses of collection, to be added to the amount due on said note, and collectible as a part thereof, if the same be placed with an attorney for collection, or if said debt, or any part thereof, be collected by an attorney or by legal proceedings of any kind.

Burgin, in consideration of the said debt and sums of money aforesaid, and for the better securing the payment thereof to the said Crtizens Building and Loan Association, Greer, S. C., according to the terms of the said note, and also in consideration of the further sum of Three (\$3.00) Dollars to the said mortgagor... in hand well and truly paid by the said mortgagee, at and before the sealing and delivery of these Presents (receipt of which is hereby acknowledged), have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Crtizens Building and Loan Association, Greer, S. C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, near the Town of Green, North of Emma Street, on the North side of Morrow Street, fronting Morrow Street 45 feet and having a depth of 150 feet, and being lot No. 18 and one-half of Lot No. 19, as shown on plat of "Morrow Park", being surveyed by A. W. Hoffman for C. L. Chandler March 1918, and being recorded in the office of R. M. C. for Greenville County in Plat Book "E", page 91, and being the same land conveyed to W. A. Pearson by Clyde Hall by deed dated November 11, 1925, and recorded in the Office of R. M. C. for Greenville County in Vol. 106, page 276.

W. Hoffman, March 1918, and being recorded in the Office of R. M. C. for Greenville County in Plat Book "E", page 91,
