WHEREAS, the Mortgagor is well and truly indebted unto FOUNTAIN INN FEDERAL SAVINGS AND LOAN ASSOCIATION OF Fountain Inn, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by

reference, in the sum of Seven Thousand and no/100

DOLLARS (\$ 7,000.00), with interest thereon from date at the rate of six per centum per annum, said principal and interest to be paid as therein stated, and

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the Town of Mauldin, known as lot no. 16 in accordance with plat made for J. W. Whitt by C. O. Riddle dated April, 1957 and being more fully described in accordance with said plat, to-wit:

Beginning at an iron pin on the northern side of Pleasant Drive, joint front corner of lots 16 and 17 and running thence N 29-45 W, 191.4 feet to an iron pin; thence N 60-38 E, 80 feet to an iron pin; thence S 29-45 E, 190.9 feet to an iron pin on edge of Pleasant Drive; thence along Pleasant Drive S 60-15 W, 80 feet to an iron pin, being the point of beginning.
