TO ALL WHOM THESE PRESENTS MAY CONCERN:

WILLIAM RAY BERRY (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of Forty-five Hundred and No/100 ----- DOLLARS (\$ 4500.00), with interest thereon from date at the rate of six (6%) per centum per annum, said principal and interest to be repaid as therein stated, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying in Chick Springs Township, on the northeastern side of road leading from Greenville to Reid School being shown as Lots 5 and 6 on plat of J. H. Roberts Estate prepared by H. L. Dunahoo dated September, 1949, and recorded in Plat Book W, Page 67, and being more particularly described as follows:

BEGINNING at the northern side of Reid School Road at the southwestern corner of Lot 7 and running thence with the line of said lot in a northeasterly direction 180 feet to an iron pin at the rear corner of Lot 2; thence with the rear lines of Lots 2 and 1 182 feet to the rear corner of Lots 1 and 5; thence with the line of Lot 5 S. 21-30 W. 263 feet more or less to southwestern corner of said lot; thence with the southern side of said lot S. 58-0 E. 16 feet to an iron pin on the northwestern side of Reid School Road; thence with the northwestern side of said road N. 72-0 E. 200 feet to the beginning corner.

Being the same property conveyed to the mortgagor by deed of C. E. Vaughn.
