

The sum of \$35.00 on the 5th day of January, 1959, and \$35.00 on the 5th day of each succeeding month until paid in full with payments applied first to interest and then to principal.

at the rate of 6 per centum per annum, to be computed and paid monthly

until paid in full; all interest not paid when due to bear
