released, and by these presents do grant, bargain, sell and release unto the said

Greenville, State of South Carolina, being known and designated as a portion of Lot 5
on plat of property of the estate of Lula Hobby Moragne, plat of which is recorded
in RMC Office for Greenville County in Plat Book T, page 165, and having the follow-
ing metes and bounds, to wit:
