"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Oneal Township, in the Mt. Lebanon Community, lying on the east side of the Gowansville Road (also known as the Wingo Road), and on the west side of a county road, being a part of what is known as the Briggs Property, being further shown as a part of the said tract as shown on a plat made by Dalton & Neves, October, 1947, having the following courses and distances, to-wit:
