Now, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, on the southern side of Paris Mountain Avenue, near the City of Greenville, being shown as Lot 33 on a plat of Ethel Y. Perry Estate, recorded in Plat Book B, Page 33, and described as follows:

BEGINNING at a stake on the southern side of Paris Mountain Avenue 65 feet west from Newland Avenue at the corner of Lot 34 and running thence with the line of said lot S. 6-02 E. 110 feet to an iron pin; thence S. 83-58 W. 60 feet to an iron pin at the corner of Lot 32; thence with the line of said lot N. 6-02 W. 110 feet to Paris Mountain Avenue; thence with the southern side of said avenue N. 83-58 E. 60 feet to the beginning corner.
