"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Chick Springs, Township, on the west side of Morrow Street in the City of Green, and being Lots Mos. 22 and 23 of Morrow Heights according to survey and plat by H.S. Brockman, Surveyor, dated September, 1935, recorded in Plat Book, page, R.M.C. Office for Greenville County, and having the following courses and distances, to-wit:

BEGINNING at the corner of Morrow Street and Rosa Street, onthe southeastern corner of Lot No. 23, and runs thence with the north side of Rosa Street, N. 77-49 W. 155 feet to a stake; corner of L.E.
