NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville, State of South Carolina:

All those lots of land in the city of Greenville, county of Greenville, state of South Carolina, known and designated as Lots Nos. 19 and 20, Section E, revised on plat of Grove Park recorded in plat book J at page 68-69 of the RMC Office for Greenville County, S. C., and having according to said plat and a recent survey made by T. C. Adams the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the southwest side of Brookway Drive, the front joint corner of Lots Nos. 18 & 19; thence with the joint line of said lots S. 57-0 W. 248 feet to an iron pin; thence N. 27-0 W. 65 feet to an iron pin corner of Lot No. 21; thence with the line of said lot N. 61-0 E. 256 feet to an iron pin on the southwest side of Brookway Drive; thence with the southwest side of said Brookway Drive S. 17-07 E. 50 feet to the beginning corner.
