Greenville, S. C. , hereinafter called the Mortgagor, send (s) greetings:

WHEREAS, the Mortgagor is well and truly indebted unto Aiken Loan & Security Company

, a corporation organized and existing under the laws of South Carolina , hereinafter called the Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Eleven Thousand Four Hundred Dollars (\$ 11,400.00), with interest from date at the rate of five & one-fourth per centum (5 1/4 %) per annum until paid, said principal and interest being payable at the office of Aiken Loan & Security Company in Florence, South Carolina , or at such other place as the holder of the note may designate in writing, in monthly installments of Sixty-eight and 40/100 - - Dollars (\$ 68.40), commencing on the first day of June , 19 59, and on the first day of each month thereafter until the principal and interest are fully paid, except that the final payment of principal and interest, if not sooner paid, shall be due and payable on the first day of May , 19 84.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell, and release unto the Mortgagee, its successors and assigns, the following-described real estate situated in the County of Greenville , State of South Carolina:

All that lot of land in the county of Greenville, state of South Carolina, being known and designated as Lot No. 5 of a re-subdivision of Lots Nos. 275, 276 and 277 of Augusta Acres subdivision as shown on plat of property of Clyde Dorr recorded in plat book SS page 107 of the RMC Office for Greenville County, S. C., and having according to said plat and a recent survey made by J. W. Hill, March 6, 1959 the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the north side of Churchill Circle, the front joint corner of Lots Nos. 5 and 6; thence with the joint line of said lots N. 27-20 W. 364.6 feet to an iron pin; thence S. 50 W. 41 feet to an iron pin the rear corner of Lot No. 7; thence with the rear corner of said lot S. 67-30 W. 13 feet to an iron pin in line of Lot No. 8; thence with the line of said lot N. 8-10 W. 79 feet more or less to a point; thence continuing with the line of said lot N. 20-14 W. 382 ft. more or less to an iron pin; thence N. 58-22 E. 153 feet more or less to an iron pin corner of Lot No. 4; thence with the line of said lot S. 20-57 E. 431.3 feet to an iron pin on the north side of Churchill Circle; thence with the north side of said Churchill Circle S. 61-12 W. 21.9 feet to a point; thence continuing S. 62-28 W. 63.5 feet to the beginning corner.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and equipment now or hereafter attached to or used in connection with the real estate herein described.

To HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its successors and assigns forever.
