BEGINNING at a pin on the South side of Park Avenue in Greer, Greenville County, South Carolina and runs thence 160 feet on line of the I.P. Few Property; thence with the Few line North 135 feet to pin, corner of Lots 8 and 9; thence West 140 feet to pin, corner of Lots 9 and 10; thence West 130 feet to pin; thence S. 165 feet to pin on Park Avenue; thence with said Park Avenue 190 feet, curving with said street to the beginning corner.

ALSO, part of Lot No. 11 on said plat beginning on the I.P.
